Dear Applicant:

We are pleased to advise you that on June 1, 2004, the California Board of Legal Specialization certified you as a legal specialist in Family Law.

Before we can issue you a certificate of specialization, the Legal Specialization rules require you to pay a certification fee, which has been set by the Board at \$100. In addition, applicants certified between December 1 and June 30 are required to pay half the \$200 annual fee for certified specialists. This fee is due 30 days from the date of this letter; please note that a late charge in the amount of \$50 will be added if the fee remains unpaid after 60 days. (See sections 20.2 - 20.4 of the Rules.)

Upon receipt of your check or money order in the amount of \$200 (\$100 for the certification fee and \$100 for half the annual fee), we will promptly forward your certification to the above address. Please remember that, until we receive the required fees, you may not hold yourself out as a certified legal specialist. If we do not receive the fees, we will assume that you no longer wish to participate in the program and will close your file.






Dear Mr. Palmer:
